1. No of vacancies : Existing And Arising Vacancies

2. Tenure of Appointment : Maximum up to 3 years subject to the performance.

3. Mode of selection : Written test/Interview

4. Nature of appointment : Temporary(purely on contract)

5. Venue : Administrative Block, MCC (PGIOSR)

6. Application Fee : Rs.100/-(for all candidates)

- 7. Selected candidate will Posted at Malabar Cancer Centre (Post Graduate Institute Of Oncology Science & Research) on contract basis.
- 8. Candidate will mark their attendance between 10.00 AM to 11.00 AM 01/09/2025 by paying Rs.100/- as application fees. Late comes will not entertained.
- 9. Candidates without **copies of originals showing age, qualification and experience** will not be considered eligible for further recruitment procedures.
- 10. Selection will be based on qualification and experience and performance in the interview. Claims in respect of Qualifications, Experience, etc. should be supported by Self Attested copies of relevant documents; Candidates should produce the originals at the time of interview.
- 11. If the number of applications are high then a written/online test will be conducted
- 12. No TA/DA will be paid for the Interview/Written test.
- 13. Canvassing in any form will lead to automatic disqualification. Candidates are advised to desist from such unholy practices.
- 14. Age will calculated from the date on 1st January of the year,i.e.**01.01.2025.**
- 15. The Experience will be calculated from the date on which requisite qualification is obtained to date

- of notification.
- 16. The Director MCC (PGIOSR) will hold the right to reject any application without any information.
- 17. Candidates if selected cannot have any claims for permanency.
