- Mode of selection : Written test/Interview
- Nature of appointment : Temporary(purely on contract)
- Venue : Administrative Block, MCC (PGIOSR)
- Application Fee : **Rs.100/-(for all candidates)**
- Selected candidate will be Posted at Malabar Cancer Centre (Post Graduate Institute Of Oncology Science & Research) on contract basis.
- Candidate will mark their attendance at **09.00 AM** on **27/10/2025** by paying **Rs.100/-** as application fees. Late comes will not be entertained.
- Candidates without **copies of originals showing age, qualification and experience** will not be considered eligible for further recruitment procedures.
- Selection will be based on qualification and experience and performance in the interview. Claims in respect of Qualifications, Experience, etc. should be supported by Self Attested copies of relevant documents; Candidates **should produce the originals at the time of interview.**
- If the number of applications are high then a written/online test will be conducted
- No TA/DA will be paid for the Interview/Written test.
