**Terms and Conditions:**

- Last date for receipt of quotations is 14/01/2026 at 12.00 PM.** Late quotations will not be accepted. The quotations will be opened at **2.00 PM on -14/01/2026** in the presence of the quotationers or their authorized representatives who may be present at that time. The maximum period required for Quality Assurance should also be mentioned.
- The bidder should have a minimum of 4 years' experience in handling such works. The documents to prove the experience (performance report/work completion report/service reports certified by the customer with sign and seal) should be submitted along with the quotation.
- The quotation should be an unconditional one and the quotationers are not permitted to impose any of their conditions, stipulations, alterations, commissions, and instructions, specify any terms for executing the work under this contract other than those specified herein. This is MCC's right to select the quotation.
- The bidder should be AERB and NABL accredited.** The documents proving the accreditation should be submitted along with the tender document. The QA of the equipments should be done and the QA report issuing should be done as per AERB

guidelines. The work should be completed within 10 days from the receipt of work order.

5. The rate quoted for QA should be tax inclusive. Extra claim in these lines will not be accepted under any circumstances.
6. The quotation documents are published on the website of MCC (PGIOSR), [www.mcc.kerala.gov.in](http://www.mcc.kerala.gov.in). The rate quoted for the QA shall be submitted in the format specified in the quotation notice.
7. The agency will have to comply with the security restrictions enforced by Malabar Cancer Centre. The directions issued by MCC (PGIOSR) should be strictly followed by the labourers so as to ensure minimum disturbance to the hospital functioning.
8. The Payment for the work will be made by cheque or RTGS or Electronic transfer on submission of Original Bills.
9. If any damage or loss occurs to MCC (PGIOSR) property while executing the work, the same shall be made good after making necessary repair/replacement works at contractor's own expense. In case the Contractor fails to do so the damage/loss/work will be got executed by MCC (PGIOSR) by other agencies at the risk and cost of the Contractor. The expense thus incurred will be recovered from the contractor by any means MCC (PGIOSR) may deem to fit.
10. The agency should take all safety precautions to avoid accidents during execution and also responsible for all damages and accidents caused due to negligence.
11. Without the written consent of us, you should not assign or sublet or transfer any part of the equipment and work either wholly or partially.
12. No hindrance shall be caused for the normal working of the hospital during the execution of above work. The work shall be done as per the instructions from Engineering dept/ RSO MCC (PGIOSR)
