INVITATION TO EXPRESSION OF INTEREST (EOI)

Malabar Cancer Centre (PGIOSR), Thalassery invites Expression of Interest (EOI) under **Two Bid System (Technical & Financial)** from experienced, competent and authorized agencies for the **dismantling, shifting, transportation and disposal** of:

- 1.5 Tesla MRI Machine with accessories (Working condition with minor defects)
- CT Scanner (Decommissioned)

The equipment will be disposed on **“As-Is-Where-Is Basis.”**

(Two bid System: Technical bid & Financial bid).

Technical Bid: The Technical bid shall contain the complete documents mentioned in the EOI form and details on the competency of the tenderer and also should submit the EOI form with the sign and seal on all the pages by the tenderer, except the Financial Bid Form.

Financial Bid: The financial bid shall be submitted in the format given in this document as Financial Bid Form. The **financial bids submitted in any other formats will be treated as non-responsive and not considered for evaluation.**

The financial Bid shall contain the ‘Financial Bid Form’ duly filled in the prescribed Performa. Only the Financial Bids of those firms qualified in the detailed scrutiny and evaluation of the technical bid evaluated by the Technical Committee/Tender Inviting Authority shall be opened.

The Technical Bid and Financial Bid should be submitted in separate sealed covers.

The bidder shall have proven experience in disposal of medical imaging equipment such as **MRI and/or CT scanners**. The bidder must have **successfully completed at least one work** involving **disposal of MRI or CT equipment** during the **last three (3) years**.

Eligibility Criteria

1. The bidder shall have proven experience in disposal of MRI/CT equipment.
2. At least **one disposal work of MRI or CT** completed during the last **3 years**.
 - Submit: Work Order / Permission Letter / Completion Certificate / Payment Proof.
3. The bidder shall be capable of dismantling, handling, transporting and disposing of the equipment in compliance with:
 - AERB norms
 - E-Waste Management Rules 2016
 - Biomedical Waste Management Rules
 - SPCB / CPCB requirements
4. Authorization for handling:
 - High field MRI magnet / cryogenic handling
 - CT X-ray tube / lead components
5. Necessary statutory undertakings to be submitted.

BACKGROUND

Malabar Cancer Centre (PGIOSR), Thalassery is an autonomous institution under the Department of Health & Family Welfare, Government of Kerala, established in 2001 under the Societies Registration Act. The Centre functions under a Governing Body chaired by the Hon'ble Chief Minister of Kerala and an Executive Committee chaired by the Health Secretary.

MCC (PGIOSR) presently has a bed strength of 354 and provides comprehensive cancer care to patients from Northern Kerala and neighboring states, serving a population of over 1.5 crore. The institution is committed to developing as a centre of excellence in cancer treatment, research, and training.

As a not-for-profit government institution, 90–97% of patients are treated either free of cost or at highly subsidized rates through various Government schemes and institutional support systems. MCC ensures that no patient is denied treatment due to financial constraints and also provides free food and accommodation facilities for patients and bystanders within the campus.

A) REQUIREMENT:

MCC (PGIOSR) proposes to dispose of one **1.5 Tesla MRI Machine** and one **CT Scanner** from the MCC (PGIOSR) campus through a duly authorized agency, in compliance with all applicable statutory and regulatory requirements.

Scope of Work of Successful Bidder

1. Dismantling under expert supervision
2. Safe handling of MRI magnet and CT components
3. Shifting, loading, transportation
4. Compliance with all statutory approvals
5. Submission of handing over certificate before gate pass
6. No disturbance to hospital functioning & Work only during permitted hours
7. Full responsibility after dismantling
8. The quoted price should be exclusive of all applicable taxes and duties. The consolidated amount for entire items should be quoted.
9. The sealed quotation should be addressed to Director, MCC (PGIOSR), Thalassery and must reach this office on or **before 4th February 2026 , 3:00 PM.**
10. The shifting of dismantled equipment, transportation and disposal of the equipment as per standards are under the scope of the successful bidder. The quoted amount should cover all the above works
11. The hospital will sell the equipment on an “as-is-where-is” basis, and bidders should satisfy themselves about the condition of the machine prior to submission of their bids.
12. The Proposal should be an unconditional one and the bidders are not permitted to impose any of their conditions, stipulations, alterations, commissions, and instructions, specify any terms for executing the work other than those specified herein. This is MCC’s right to select the Bid.
13. MCC –PGIOSR will issue the work order to the successful bidder. That agency will be responsible for dismantling, shifting, and transportation of the equipment at their own cost and risk.
14. Without the written consent/permission letter from MCC (PGIOSR), you shall not commence the work, either wholly or partially. If your workers cause any damage or loss to MCC property, you will be held responsible for making good the damage/loss. In case MCC has to get the work executed through another agency due to such issues, the cost incurred will be recovered from you in addition
15. The agency should inform us at least seven working days prior to the commencement of the work to enable necessary internal arrangements. The work schedule should also be submitted at least one week in advance
16. All the work should be carried out under the supervision of an authorized representative of the company, from dismantling to the removal of the machine from the premises. The company representative must have sufficient experience in handling the dismantling and removal of the MRI scanner and related equipment. An authorization letter from the company should be submitted to the Engineer-in-Charge before commencing the work.
17. The agency should take all safety precautions to avoid accidents during execution and also responsible for all damages and accidents caused due to negligence.

18. There should be no disturbance to patients or disruption to the functioning of the hospital. The dismantling work, movement of dismantled items, and loading/unloading must be carried out only during the time specified by the Engineer-in-Charge.
19. All responsibility for the machine, after dismantling from the premises, lies with the agency. The agency must submit a handing over certificate on their official letter head. Only upon submission of this certificate MCC (PGIOSR) will issue the gate pass. MCC (PGIOSR) will not bear any responsibility for the equipment after it has been dismantled..
20. The agency should obtain all necessary approvals from the competent and authorized authorities to carry out the dismantling, shifting, and transportation of the equipment. All related documentation and financial implications for the above work shall be the responsibility of the agency
21. The hospital reserves the right to reject any or all quotations without assigning any reasons.
22. The hospital will sell the equipment on an 'as-is-where-is' basis, and bidders are advised to satisfy themselves regarding the condition of the machine before submitting their bids. The agency may inspect the equipment on all working days between 09:30 AM and 04:30 PM, with prior permission from the Engineer-in-Charge
23. All expenses related to dismantling, loading, and transportation shall be borne by the successful bidder and necessary approval should be taken from various government and other statutory bodies if required
24. Payment terms: Advance payment of 80% of the contract amount and balance payment 20% at the time of pickup of the MRI/CT system.

- AERB authorization (CT & MRI handling)
 - E-Waste Management authorization (CPCB/SPCB)
 - Biomedical Waste Rules compliance
 - Cryogenic / Helium handling authorization
25. The agency will be responsible for all kinds of payments to the workmen/service personnel as per rules and regulations, which are in force from time to time and for the safety of the laborers employed by them. The agency shall alone be liable to pay all such liabilities. The agency should ensure that their employees do not make any disturbance to the functioning of the hospital during execution of the work and also required to comply with the provisions of all statutory and legal requirements of Central and State Governments and other agencies applicable to the work as well as any local regulations applying to the site.
 26. Security norms: The agency will have to comply with the security restrictions enforced by MCC (PGIOSR). The directions issued by us should be strictly followed by your service personnel so as to ensure minimum disturbance to the hospital functioning.
 27. All disputes arising out of or in connection with this work shall be deemed to have arisen in Thalassery, Kerala, and only the courts at Thalassery in Kerala shall have jurisdiction to resolve them.

28. In addition to the above terms and conditions the rules and regulations of the Government of Kerala applicable from time to time shall also be applicable to this contract.

29. The bidder can Quote Individual Equipment. The H1 bidder for each equipment item will be considered separately for awarding the contract.
